Photography Contract

This Photography Contract (the "Contract") is entered into between Krupp Imaging (the "Photographer") and _____ (the "Client") on the date of _____ (the "Effective Date").

1. *Services Provided*

The Photographer agrees to provide the Client with photography services as agreed upon, which is a **[Package]** session. The Photographer will deliver the agreed-upon number of high-resolution digital photographs to the Client within the specified timeframe via a Google Photos album.

2. *Date, Time, and Location*

The Services will be performed on **[Date]** at **[Time]** at the following location(s): **[Location(s)]**. The Client shall ensure that the location(s) is/are accessible and suitable for the Services.

3. *Additional Outfits, People and Pets*

All additions must be approved by the Photographer by written consent before the day of the event or photoshoot. Each additional outfit requires a minimum of 30 minutes and each additional person and pet are \$25.00, which will be added to the final transaction price.

4. *Mileage and Travel Studio*

The Client understands that a \$0.50 standard mileage fee will be applied to all locations outside Oakland County, Michigan, USA. The Travel Studio includes a backdrop of choice, considering what's available, which may be included for a \$50.00 standard fee. There must be an electrical outlet available to use the studio light.

5. *Payment Terms*

The Client agrees to pay the Photographer the total fee of **[Price]** for the Services. A 25% non-refundable deposit of **[Price]** is due upon signing this Contract, with the remaining balance payable on or before the day of the event. Payment shall be made in cash, check, or other legally agreed-upon transaction.

6. *Cancellation and Rescheduling*

All cancellations and reschedules must be requested and documented 48 hours before the scheduled photoshoot date and time for the deposit to be eligible for a refund. All cancellations and reschedules requested after the provided deadline are not subject to a refund. Furthermore, all reschedules must be completed within one month of the original scheduled photoshoot date and time. In the event that the Photographer is unable to perform the Services due to unforeseen circumstances, the Photographer will make reasonable efforts to reschedule. If rescheduling is not possible, the Photographer will refund the Client any fees paid.

7. *Image Ownership and Usage*

The Photographer retains the copyright and ownership of all images captured during the event. The Client is granted a non-exclusive license to use the images for personal use only, including printing, sharing on social media, and personal websites. Commercial use of the images is strictly prohibited unless otherwise agreed upon in writing.

8. *Model Release*

The Client grants the Photographer the irrevocable and unrestricted right to use and publish images taken during the event for any lawful purpose, including but not limited to marketing, advertising, portfolio, website, and publication. The Client releases the Photographer from any claims, damages, or liability related to the use of the images.

9. *Photo Retouching and Delivery*

The Photographer will use professional judgment to select and edit the images to be delivered to the Client. All images forego Standard Retouching for a cost of \$50.00 added to the final transaction price. The final edited images will be delivered to the Client within two weeks of the photoshoot date via a Google Photos album. The Photographer is not responsible for providing raw or unedited images, or changing the retouching completed on any final images.

10. *Limitation of Liability*

The Photographer will take reasonable care in capturing and delivering the images, but in no event shall the Photographer be liable for any loss, damage, or injury arising from the performance of the Services or the use of the images. The liability of the Photographer is limited to the amount paid by the Client under this Contract.

11. *Governing Law and Jurisdiction*

This Contract shall be governed by and construed in accordance with the laws of Michigan, United States of America. Any disputes arising out of or in connection with this Contract shall be subject to the exclusive jurisdiction of the courts of Michigan, United States of America.

12. *Entire Agreement*

This Contract constitutes the entire agreement between the Photographer and the Client, superseding any prior agreements or understandings, whether written or oral, relating to the Services. Any modifications or amendments to this Contract must be in writing and signed by both parties.

By signing below, the parties acknowledge that they have read, understood, and agreed to the terms and conditions of this Photography Contract.
